TERMS AND CONDITIONS

The Offer

Tap By Tap (a project of City Green, the Capital Regional District, and FortisBC) will provide up to 3,000 high efficiency showerheads, 3,000 high efficiency kitchen faucet aerators, and 3,000 high efficiency bathroom aerators to eligible buildings to achieve measurable energy and water use savings. Subject to availability, eligible buildings will receive the following:

- 1. High efficiency fixtures for eligible residential units, including:
 - a. 5.7 L/min showerheads
 - b. 5.7L/min faucet aerators for use in kitchen sinks
 - c. 3.8 L/min faucet aerators for use in bathroom sinks
- 2. One roll of thread seal tape
- 3. Installation instructions and a tracking sheet

Eligibility

Only buildings that meet the following eligibility criteria may participate in Tap By Tap, on a first-come, first-served basis while supplies last:

- 1. Has submitted a complete application form.
- 2. Is located in the Capital Regional District.
- Is a multi-unit residential building with five or more units. This
 includes apartment buildings, condominiums, and mixed-use
 buildings. Rowhouses are not eligible.
- 4. Provides a site contact person such as a building manager or site manager who is knowledgeable about the building, able to install or arrange for the installation of the high efficiency fixtures in residential units, and is available during business hours to discuss participation in Tap By Tap.
- Is not eligible for the Energy Conservation Assistance Program (ECAP) for low-income housing providers.

Commitment

By applying to participate in Tap By Tap you agree to do the following:

- 1. Arrange to access fixtures from City Green.
- 2. Install high efficiency fixtures in the building listed on the application form
 - Where technically feasible and not prohibited by any agreement with the resident;
 - b. According to provided installation instructions; and
 - c. Within one month of receiving fixtures.
- Complete and return, within one month of receiving fixtures, a data collection sheet tracking the number and type of fixtures installed in each unit.
- 4. Return unused fixtures as directed by City Green.
- Collect showerheads from units in which Tap by Tap showerheads were installed, and relinquish them to City Green as directed (for data collection and recycling purposes).
- Display Tap By Tap poster provided in a high traffic common area for at least two weeks.
- 7. Complete a short participant satisfaction survey (approximately five questions).

Limitations

In addition to the eligibility criteria above, the offer is limited as follows:

- A maximum of 3,000 high efficiency showerheads, 3,000 high efficiency kitchen faucet aerators, and 3,000 high efficiency bathroom aerators are available to multi-unit residential building units.
- Fixtures will be allocated to participating buildings on a first come first served basis.
- The Tap By Tap program reserves the right to limit the number of fixtures allocated to a building, complex, or property management firm.

 City Green may amend, modify, or terminate this Program at any time based on funding limitations or for any other reason, without notice.

- 5. By signing this form you consent to FortisBC, the CRD, or City Green Solutions contacting you (by phone, email, direct mail, or similar method) for the purposes of program evaluation, rebate administration, updates and promotions regarding FortisBC's products, services, programs and any associated business opportunities.

Disclaimer and Release

- The Tap By Tap program makes no representation or warranty, express or implied, relating to any fixture or to the availability, competence, workmanship, or financial status of any installer.
- By signing this application form, you consent to City Green collecting showerheads replaced through Tap By Tap for disposal and indicate your understanding that upon exchange, after three months the old showerheads will be recycled by City Green and cannot be returned after that time.
- 3. By signing this application form, you will be taken to have fully and unreservedly released FortisBC, the CRD, and City Green with respect to any claims for costs and liabilities arising from or in relation to the preparation for and/or the replacement of any fixture and the installation and/or use of any fixture for the purposes of participating in this high efficiency fixture exchange program including, without restrictions, all costs and all liabilities for any and all loss or damage, whether direct, special, consequential, indirect, or of any other nature.
- 4. By signing this application form, you indicate your understanding that FortisBC, the CRD, and City Green make no representation or warranty, whether expressed or implied, in respect of any of the improvements made to the building listed on this form as part of this Program, including no assurances or

- guarantees as to the energy or water savings realizable upon the Program's completion.
- 5. In consideration for participating in Tap By Tap, you hereby irrevocably waive any and all claims that you have or may in the future have against, and irrevocably release from liability and agree not to sue, FortisBC, the CRD, or City Green, and their respective affiliates, partners, subsidiaries, and agents as well as their shareholders, directors, officers, and employees for any type of loss or damage that may arise directly or indirectly in connection with your involvement in Tap By Tap.
- 6. By applying to or participating in the Tap by Tap program, you acknowledge that the high efficiency showerhead(s) may use less natural gas and produce fewer emissions. Unless

mandated by legislation or regulation to claim any environmental attributes associated with the reduction in emissions, you agree that FortisBC will own any environmental attributes associated with the reduction in emissions from the high efficiency showerhead(s) and at FortisBC's own cost, it will administer any environmental attributes, including, but not limited to, GHG offsets associated with the installation of the high efficiency fixtures(s) in gas heated buildings, which may include quantifying, validating, and registering the environmental attributes or GHG credits, and retention or disposition to third parties of the associated environmental attributes or GHG credits.
